The Cornish Association of Businesses (CAB) is pleased to announce that the 2nd Annual Cornish Community Harvest & Bazaar is taking place at the Cornish Fairgrounds. It has been scheduled for Saturday, July 29th, 2017. The event is open to the public from 8 am-3:00 pm – RAIN OR SHINE.

Space Rent for Early registration is \$15.00, registration form and payment is due before May 1st. Spaces will be sold on a first come first serve basis. NO spaces will be held or reserved without payment in full.

Space RENT after May 1st is \$25, registration contract and pay in full by July 14, 2017.

Spaces measure 15'x15'. Exhibitors supply their own tent, tables, and chairs. There are limited electricity & drinking water hookups available. Reserve early if you need electricity or water.

ATTN: FOOD VENDORS/FOOD SALES- you must attach a copy of your current license to your registration form if you are selling food for profit. Non-profit organizations are exempt from this.

We reserve the right to refuse any entry.

EXHIBITOR SET UP starts at 6:30 am on day of event. Vendors must handle their own set up. We do not provide manpower to help vendors with loading and unloading. PARKING is available behind vendor space. No one will be permitted to move vehicles from their space until 3:15 pm for safety reasons. Spaces will be assigned at arrival.
